Extension of Period of Stay - “Student” status

Those wishing to proceed to a higher level or continue studying in Japan must apply for an extension. Applications are accepted three months before the expiration of your period of your stay by the Immigration Bureau. Complete the following formalities 1~3 by the expiration date as noted on your Residence Card and submit the copy of your new card (both sides) to the International Student Section. Don't forget to submit the renewed card to the International Student Section after the extension is allowed.

1. Prepare the following documents and submit them to the International Student Section and obtain the Forms “For organization part 1 and part 2” of the application.

	Documents certifying financial support to stay/study in Japan (Certificate of scholarship, Copy of bank book, or bank balance certificate, etc.)

[Issue of Certificates]

❑ Certificate of Enrollment/Transcript/Course Registration Certificate

- ♦ Regular students can obtain them from the Certificate-Issuing-Machine in the Students Service Center.
- ♦ Doctoral course students can apply/obtain course registration certificate and copy of Notification of Extension of Enrollment period /Request for Leave of Absence at the counter in the Student Service Center.
- ♦ Research students can apply/obtain certificates at the counter in the Student Service Center.

❑ Scholarship Certificate

- ♦ Honors Scholarship/UTokyo Fellowship/UTokyo Foundation Scholarship, apply/obtain at the counter in the Students Service Center.
 - ♦ MONBUKAGAKUSHO Scholarship certificate:

- *Depending on the certificate it may take 1 ~ 10 days to be issued.

2. Receive the documents at the International Student Section.

International Student Section will check your documents and issue the Forms “For organization part 1 and part 2”. Please note that this process may take a few days.

3. Apply to the Immigration Bureau.

Submit all the documents (received at the International Student Section), along with the fee (¥ 4,000).

*The Immigration Bureau may request other documentations.

4. Submit a copy of Residence Card (both sides) to the International Student Section when your period of stay is successfully extended.

[Important note]

- ♦ You will be considered an illegal immigrant if you overstay your period of stay by even just one day, so be sure to pay attention to your period of stay and apply for an extension as early as possible.
- ♦ The Immigration offices tend to be crowded around the start of the academic year and during long break, such as summer break, so it is advisable to apply as soon as you get ready.
- ♦ The maximum length a research student can stay on a residence status of Student is 2 years including any period spent as a research student at any other universities.

<Leave of Absence>

- ♦ The Immigration Bureau decides whether or not you can remain in Japan during the leave of absence. Also, activities such as part time work won't be permitted during your leave. Please consult with us before taking a leave of absence.
