Application Guideline—Doctoral Course in Veterinary Medical Sciences Academic Year 2026

The Doctoral Course in Veterinary Medical Sciences is a 4-year course.

Our educational and research missions:

The Graduate School of Agricultural and Life Sciences aims to promote advanced education and research in the fields of agricultural and life sciences and nurture highly specialized human resources that can tackle the diverse range of food and environmental issues in the world.

Students we seek:

- Students who have the will and capabilities to tackle the diverse and sophisticated issues surrounding food and the environment challenging agricultural and life sciences.
- Being enthusiastic about acquiring advanced and cutting-edge expertise, improving research capabilities, and disseminating research outcomes to the world.

Selection policy:

Below are the basic criteria for the selection,

- Having advanced and specialized knowledge in the field of his/her choice, extensive knowledge across disciplines in agricultural and life sciences, and English language proficiency for disseminating information globally.
- Having the willingness and sufficient capability to work independently to acquire knowledge and discover problems.
- Possess basic leadership skills related to his/her area of expertise.

1. Eligibility Requirements

【General Admissions】

To be eligible for admission, the applicant must meet one of the following conditions.

- (1) Those who have graduated, or are expected to graduate by March 31, 2026, from a program in veterinary medical science or pharmacy requiring 6 years of university study at a Japanese university. (Note 1)
- (2) Those who have graduated, or are expected to graduate by March 31, 2026, from a program in medicine or dentistry at a Japanese university. (Note 1)
- (3) Those who have completed, or are expected to complete by March 31, 2026, 18 years of school education in a foreign country. The final program must be veterinary medical science, medicine, dentistry or pharmacy. (Note 2)
- (4) Those who have earned or are expected to earn a bachelor's degree or its equivalent from a foreign university or other foreign institution of higher education (limited to institutions accredited by the government of a foreign country or a related organization), having completed a program of 5 years or more (restricted to programs in veterinary medical science, medicine, pharmacy or dentistry). (Note 2)
- (5) Those designated by the Minister of Education, Culture, Sports, Science and Technology or those who have completed or are expected to complete a program at an educational institution, etc., designated by the Minister of Education, Culture, Sports, Science and Technology by March 31, 2026. (Note 3) (Note 4)
- (6) Those who have completed 16 years of school education including a course in veterinary medical science, medicine, dentistry or pharmacy in a foreign country, or those who have completed 16 years of education of a foreign country through correspondence courses provided in Japan by a foreign school of the said country, including a course in veterinary medical science, medicine, dentistry or pharmacy, and who are recognized by this graduate school as having completed the required courses with excellence. (Note 4)

- (7) Those who have completed a program at an educational institution in Japan designated by the Minister of Education, Culture, Sports, Science and Technology that provides courses of a foreign university that is an accredited institution under the school education system of a foreign country and are recognized by this graduate school as having completed prescribed academic units with excellent results. This applies solely to those who have completed 16 years of school education in said foreign country and have the final degree in veterinary medical sciences, medicine, dentistry or pharmacy. (Note 4)
- (8) Those who are 24 years or older as of March 31, 2026, and who are recognized by this graduate school through individual screening of entrance qualifications as having abilities that are equivalent or superior to those who have graduated from a Japanese university. (Note 1) (Note 5)

【Special Admissions for Working Adults】

To be eligible for admission, the applicant must meet any one of the following conditions (1) to (8), and must be currently employed at government offices, schools, companies, etc., at the time of application, and must expect to continue to be employed after admission. (Note 6)

- (1) Those who have graduated from a program in veterinary medical science or pharmacy requiring 6 years of university study at a Japanese university. (Note 1)
- (2) Those who have graduated from a program in medicine or dentistry at a Japanese university. (Note 1)
- (3) Those who have completed 18 years of school education in a foreign country. The final program must be veterinary medical science, medicine, dentistry or pharmacy. (Note 2)
- (4) Those who have earned or are expected to earn a bachelor's degree from a foreign university or other foreign institution of higher education (limited to institutions accredited by the government of a foreign country or a related organization), having completed a program of 5 years or more (restricted to programs in veterinary medical science, medicine, pharmacy or dentistry). (Note 2)
- (5) Those designated by the Minister of Education, Culture, Sports, Science and Technology or those who have completed a program at an educational institution, etc., designated by the Minister of Education, Culture, Sports, Science and Technology. (Note 3) (Note 4)
- (6) Those who have completed 16 years of school education including a program in veterinary medical science, medicine, dentistry or pharmacy in a foreign country, or those who have completed 16 years of education of a foreign country through correspondence courses provided in Japan by a foreign school of the said country, including a program in veterinary medical science, medicine, dentistry or pharmacy, and who are recognized by this graduate school as having completed the required programs with excellence. (Note 4)
- (7) Those who have completed a program at an educational institution in Japan designated by the Minister of Education, Culture, Sports, Science and Technology that provides programs of a foreign university as an accredited institution under the school education system of a foreign country, and are recognized by this graduate school as having completed prescribed academic units with excellent results. This applies solely to those who have completed 16 years of school education in said foreign country and have the final degree in veterinary medical sciences, medicine, dentistry or pharmacy. (Note 4)
- (8) Those who are 24 years or older as of March 31, 2026, and who are recognized by this graduate school through individual screening of entrance qualifications as having abilities that are equivalent or superior to those who have graduated from a Japanese university. (Note 1) (Note 5)

(Note 1) Japanese universities mentioned in conditions (1), (2) and (8) above are universities within the boundaries of Japan as prescribed in Article 83 of the School Education Act.

(Note 2) Conditions (3) and (4) above include having completed a correspondence program provided by a foreign school of said country while residing in Japan.

(Note 3) Those designated by the Minister of Education, Culture, Sports, Science and Technology in (5) above correspond to the following persons.

- ① Those who have studied medicine or dentistry at the faculty of medicine or dentistry of a university according to the former university ordinance and who have graduated from such faculty.
- ② Those who have graduated from the National Defense Medical College under the Act for Establishment of the Ministry of Defense.
- ③ Those who have completed a Master's course or a professional graduate course in Japan, those who are eligible to receive a Master's degree, and those who have been enrolled in a doctoral course without junior and senior divisions for two years or more, have acquired 30 credits or more, have received the necessary research guidance, and have been recognized as having equivalent or higher

academic ability than those who have graduated from a university program in medicine, dentistry, pharmacy with emphasis on cultivating practical clinical skills, or veterinary medicine.

- ④ Those who have graduated from a Japanese university (excluding programs in medicine, dentistry, pharmacy with emphasis on cultivating practical clinical skills, and veterinary medicine) or those who have completed 16 years of school education in a foreign country and who have been engaged in research at a university, research institute, etc., for 2 years or more, and have been recognized by the graduate school or the department, through the results of said research, etc., as having equivalent or higher academic ability than those who have graduated from a university program in medicine, dentistry, pharmacy with emphasis on cultivating practical clinical skills, or veterinary medicine.
- ⑤ Those who have completed a program at a foreign university (limited to those who are deemed to have completed 18 years of school education in said country, the final course being veterinary science, medicine, pharmacy or dentistry).

(Note 4) Those who wish to apply according to conditions (5), (6), or (7) should contact the Graduate Student Section, Academic Affairs Division, Graduate School of Agricultural and Life Sciences (see 13. Inquiries and Contacts) by the following dates.

Schedule A: Wednesday, May 7, 2025

Schedule B: Wednesday, October 8, 2025

(Note 5)

- ① Those who do not fall under (1) through (7) of the eligibility conditions, but who have graduated (completed) a course in veterinary medicine, medicine, dentistry, or pharmacy at an educational institution equivalent to a six-year university, and who are deemed by the Graduate School to have academic ability equivalent or superior to those listed in (1) or (2) of the eligibility conditions, through an individual screening of eligibility for admission.
- ② Applicants who intend to apply under condition (8) are required to submit an application to the Graduate Student Section, Academic Affairs Division, Graduate School of Agricultural and Life Sciences (see 13. Inquiries and Contacts) by the following dates.
Schedule A: Wednesday, May 7, 2025
Schedule B: Wednesday, October 8, 2025
- ③ Those who are recognized through individual screening of entrance qualifications as having abilities equivalent or superior to those specified in conditions (1) or (2) above will be permitted to apply and take the entrance examinations.

(Note 6) Those who are admitted through the Special Admissions for Working Adults must remain employed after admission. Applicants who plan to leave their jobs after admission should apply for the general selection. The following cases are not eligible for the Special Admissions for Working Adults: If you take a leave of absence after enrollment, if you are employed part-time or are a part-time staff, if you work freelance, if you plan to change jobs and have not yet confirmed your position after enrollment, etc. Please also refer to 12. Notes (6).

2. Admission Period

(1) Schedule A: October 2025 and April 2026

(Students who apply Schedule A may choose to enroll in either October 2025 or April 2026. However, October admission is limited to those who have obtained or expect to obtain the above qualifications by September 2025. For those who wish to enroll in October 2025 for Schedule A, replace March 31, 2026, with September 30, 2025, in (1) through (3), (5), and (8) of the above section 1.)

(2) Schedule B: April 2026 and October 2026

(Students who apply Schedule B may choose to enroll in either April 2026 or October 2026. For those who wish to enroll in October 2026 for Schedule B, replace March 31, 2026, with September 30, 2026, in (1) through (3), (5), and (8) of the above section 1.)

3. Selection Method

【General Admissions】

Selection is based on evaluation of the examinations of Foreign Language (English) test, Special Subjects, Oral examinations (about the field of specialization), and screening of submitted documents including Research Proposal and scholastic records issued by all universities or colleges attended.

【Special Admissions for Working Adults】

Selection is based on evaluation of the examinations of Foreign Language (English) test Special Subjects, Oral examinations, scholastic records issued by all universities or colleges attended, and screening of submitted documents including Research Proposal.

※In the General Admissions and the Special Admissions for Working Adults examinations, questions may be in Japanese or English and answers may be given in Japanese or English as the examinee prefers.

4.Application Procedures and Application Period

There are two application periods, Schedule A and Schedule B, as described in (3) below.

If an applicant is eligible to apply for both dates, he/she is not precluded from applying for both during the respective application periods. Applicants who wish to enroll in October 2025 should apply according to Schedule A, and applicants who wish to enroll in October 2026 should apply according to Schedule B.

(1) The application form and other documents must be prepared and submitted through the Web Entry system.

- (1) A small number of students will be selected in the Special Admissions for Working Adults.
- (2) Depending on the results of the examination, the actual number of successful applicants may not reach the number of students to be admitted.
- (3) Also refer to the information on the major's website listed under "Contact Information for the Department".

7. Foreign Language (English) Examination

Foreign language (English) examination is conducted using TOEFL-ITP in a face-to-face setting. TOEFL-ITP is the TOEFL program for groups. The Graduate School uses TOEFL-ITP (LEVEL 1). The test is divided into three sections, Listening Comprehension: 50 questions, Structure and Written Expression: 40 questions, and Reading Comprehension: 50 questions, and takes approximately two hours. If any section is left unanswered (unmarked), the entire three sections will not be scored.

The technical sections will be given in both Japanese and English. Unless otherwise specified in the question instructions, answers should be written in either Japanese or English.

(Note) The original transcripts and graduation certificate uploaded at the time of application must be kept in a safe place so as not to lose them, as they will be required at the time of admission procedures.

9. Payment of the examination fee

- (1) Payment must be made by bank transfer, at a convenience store, by credit card, or through a Pay-easy-enabled ATM, Pay-easy-enabled online bank, or Internet only bank. In all cases, please note that you are responsible for bank transfer and payment fees.
- (2) Japanese Government (Monbukagakusho) Scholarship foreign students are not required to pay this fee.

【Payment by bank transfer】

Fill out the prescribed bank transfer request form and transfer the funds from the nearest financial institution (payment through Japan Post Bank or post offices are not accepted) (do not use ATMs or the Internet, except in the case of payment by the prescribed method at ATMs that support PayGee, Internet banks that support PayGee, or specialized Internet banks – see below for details). When transferring the payment, the applicant must receive a bank transfer receipt (Form B) and a certificate of receipt of the application fee (Form C) and submit the certificate of

receipt of the application fee (Form C) pasted on the prescribed form (downloadable from the Graduate School's website: https://www.a.u-tokyo.ac.jp/grad/grad_applicants2.html) and submit it. The Certificate of Receipt of the Examination Fee Payment (Form B) is the receipt of the payment, so please keep it in a safe place.

【Payment at a convenience store or by credit card】

Payment through convenience stores are limited to Seven-Eleven, Lawson, FamilyMart, and Ministop. VISA, MasterCard, JCB, and American Express credit cards are accepted.

For the actual payment procedure and precautions, please refer to the attached "How to Pay the Application Fee for the Graduate School of Agricultural and Life Sciences, The University of Tokyo", pay the application fee and submit it according to the instructions. Please take good care of the certificate of receipt, etc., required for application.

【Payment at Pay-easy enabled ATMs, Internet banks, and Internet-only banks】

Please refer to the attached "How to Pay the Application Fee for the Graduate School of Agricultural and Life Sciences, The University of Tokyo" for the operation procedures and precautions regarding payment. After payment, access the "Application Details Inquiry" on the E-payment site, enter the [Receipt Number] you were notified of when the application was received and your [Date of Birth], print out the inquiry results, and submit them.

*If you wish to apply for an exemption from the examination fee due to damage caused by earthquakes, typhoons, windstorms, floods, or other disasters in Japan, please contact the Graduate Student Section, Academic Affairs Division, Graduate School of Agricultural and Life Sciences, in advance (see Section 13. of the Inquiries and Contacts). A certificate issued by a public institution is required.

10. How to enter the Web Entry System

- (1) All designated fields must be filled in. If any field is not filled in, it will be treated as an incomplete application.
- (2) Please refer to the "List of faculty members and their specialties" and enter up to your third choice in a different field of specialization. No more than two fields of specialization may be entered in the first through third choice columns. If there are any changes in the names of faculty members, etc., please check the latest version of the "List of faculty members and their specialties" in the Application Guidebook before applying.
- (3) Be sure to enter the name of the subject to be selected in the Examination Subject field.
- (4) Enter your history up to the date of expected graduation from college or university. Applicants for the Special Admissions for Working Adults must also enter their employment history.
- (5) If you have jumped years or were educated outside Japan, please contact the Graduate Student Section, Academic Affairs Division, Graduate School of Agricultural and Life Sciences (see 13. Inquiries and Contacts) before submitting your application.

11. Announcement of Successful Applicants and Admission Procedures

(1) Schedule A

- ① Successful applicants will be notified at 10:00 a.m. on Tuesday, September 2, 2025, on the My Page of the Web Entry System. No telephone inquiries will not be accepted.
- ② Applicants will be notified of the admissions results according to the following schedule.
 - Students admitted in October 2025: Notification will be made in early September 2025.
 - Students admitted in April 2026: Notification will be made in late February 2026.

(2) Schedule B

- ① Successful applicants will be notified at 10:00 a.m. on Thursday, February 19, 2026, on the Web Entry System My Page. No telephone inquiries will not be accepted.
- ② Applicants will be notified of the admissions results according to the following schedule.
 - Students admitted in April 2026: Notification will be made in late February 2026.
 - Students admitted in October 2026: Notification will be made in early September 2026.
- (3) Those who have been notified of admission in October 2025 must complete the admission procedures (submission of admission documents and payment of admission fee) within the prescribed period in early September 2025. Those who have received notification of admission in April 2026 must complete the admission procedures (submission of admission documents and payment of admission fee) within the designated period in early March 2026. Those who have received notification of acceptance for admission in October 2026 must complete the admission procedures (submission of admission documents and payment of the admission fee)

within the prescribed period in early September 2026. Please note that if you do not complete the enrollment procedures within this period, you will be deemed not to have enrolled in the program.

(4) Expenses required at the time of admission (estimated amount for the fiscal year 2026)
(No fees will be collected from students on Japanese Government (Monbukagakusho) Scholarship)

① Admission fee: JPY 282,000 (tentative)

② Tuition fee for the first semester: JPY 260,400 (annual amount: JPY 520,800) (tentative)

The above payment amounts are estimated amounts. If the student fees are revised at the time of admission or while the student is enrolled, the new payment amounts will be applied from the time of the revision.

12. Notes

- (1) Applicants may not apply for both the General Admission and the Special Admission for Working Adults in the same entrance examination on the same schedule in the same year.
- (2) Applicants may not apply for more than one department within the Graduate School (such as by applying for Veterinary Medicine and another department) on the same entrance examination schedule.
- (3) Incomplete applications will not be accepted, and no corrections are permitted after the application period. Examination fees are not refundable.
- (4) The examination voucher can be printed out from the Web Entry System. You must print out the "Examination ID Card" on paper (plain A4 paper, either color or black and white, but be sure to print it so that the applicant's photograph is clearly visible) by the day before the examination and bring it with you on the day of the examination.
- (5) Examinees' Guideline will be sent to all applicants in early July 2025 for Schedule A, and early January 2026 for Schedule B. If the documents have not arrived by July 16, 2025 (Wed) for Schedule A or January 14, 2026 (Wed) for Schedule B, contact the administrative department immediately.
- (6) Those who wish to enter the University while still being employed at a government agency, school, company, etc. must submit a written pledge (any form) to the effect that you will devote yourself to your studies during the period of enrollment at the time of admission procedures.
- (7) The University of Tokyo has "University of Tokyo Export Security Control Regulations" based on the Foreign Exchange and Foreign Trade Act and implements strict export security control on the providing of technology and the export of cargo, before and during enrollment of its students. In particular, international students and some Japanese students are required to undergo screening prior to acceptance.
Please note that if a student falls under any of the items regulated by the Foreign Exchange and Foreign Trade Act, even if the student has been accepted through the selection process of the entrance examination, the student may not be allowed to enroll, or may have restrictions imposed on the student's desired research activities.
- (8) The University of Tokyo provides reasonable accommodations to ensure that individuals with disabilities are not disadvantaged during entrance examinations and studies after enrollment, and provides consultations for this purpose. Those who wish to request accommodations for entrance examinations should contact the Graduate Student Section, Academic Affairs Division, Graduate School of Agricultural and Life Sciences (see 13. Inquiries and Contacts) for Schedule A by May 7, 2025 (Wed), and for Schedule B by October 8, 2025 (Wed). Although requests made after the above deadline will still be considered, it is recommended that applicants send their requests well in advance as it may not be possible to provide certain accommodations without sufficient preparation time. - (9) Those who wish to enroll in a long-term course of study beyond the standard term of study (Long-term Enrollment Student System) should contact the Graduate Student Section, Academic Affairs Division, Graduate School of Agricultural and Life Sciences (13. Inquiries and Contacts), by May 8, 2024 (Wed.) for Schedule A and October 9, 2024 (Wed.) for Schedule B. by October 9, 2024 (Wed.).
- (10) Foreign nationals must have a status of residence that allows for admission to the graduate school under the Immigration Control and Refugee Recognition Act (Cabinet Order No. 319 of 1951) by the time of enrollment . In particular, foreign nationals who are residing in a foreign country who apply for Schedule A and admission in October 2025 should be aware that due to the short period between the announcement of acceptance and admission, they may not be able to enter Japan before that admission date. It is the same attention for applicant for Schedule B and admission in April 2026.
- (11) The admission fee is not refundable once enrollment procedures have been completed.

- (12) Names, addresses, and other personal information obtained in the application process will be used for the following purposes: ① selection of applicants (application processing and selection), ② announcement of acceptance, and ③ enrollment procedures.
- The same personal information will be used for the following purposes only for those who are admitted: ① educational affairs (student registration, study, etc.), ② student support (health management, employment support, tuition waiver/scholarship applications, library use, etc.), and ③ tuition fee collection. Selection results may be used for future improvement of both admission procedures and education programs at the University of Tokyo.
- If any of the submitted documents are found to be falsified, admission may be cancelled even after enrollment.
- (13) Selection methods, examination dates and venues may change due to infectious diseases, disasters, or other such events. In such a case, an announcement will be made on the Graduate School's website.
- (14) In principle, once submitted, application documents will not be returned.
- (15) Past exam questions may be viewed at the Graduate Student Service Center of the Graduate School of Agriculture and Life Sciences.

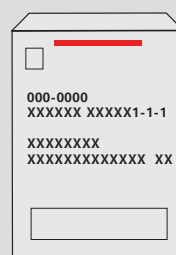
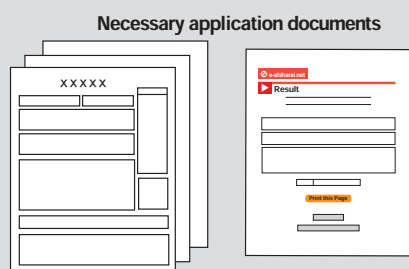

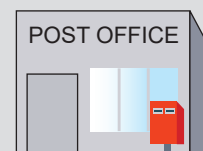
