2. Written Examinations

(1) Foreign Language (English)

Submit official TOEFL-iBT or TOEFL-iBT Home Edition scores.

For details, please refer to "7. Foreign Language (English) Examination" in the Application Guideline.

(2) Specialized Subjects

Submit documents outlining applicants' future research plans and past research activities.

3. Oral Examination

The exam will be conducted online.

4. Examination Dates

The examination will be held from Thursday, January 29 to Friday, February 6, 2026. Notification on the date, time, and other details of the examination will be provided in the "Instruction of Examination" to be sent to examinees by e-mail in early January 2026.

5. Documents to be submitted

Documents to be submitted should be (a) through (k) and (m) in accordance with the "10. Application Documents" in the Application Guideline. How to submit (m) will be provided in the "Instruction of Examination" to be sent to examinees by e-mail in early January 2026.

6. October Admission
